PRECONDITION

The precondition allows you to see which message this business rule applies to.

EXAMPLE

Precondition :

BUSINESS RULES GRAMMAR

EXPRESSION

Expression is a block that (normally) returns True or False. It can be used to make assertions about the xml under validation or as a condition of an if statement.

COMPARISON

Equal

The equal expression allows you to check that the value associated with an xpath is equal to another value.

```
<value> == <value>
```

Inequal

The unequal expression allows you to check that the value associated with an xpath is different than another value.

`<value> != <value>`

Greater than

The greater than expression allows you to check that the value associated with an xpath is greater than another value.

`<value> > <value>`

Greater than or equal to

The greater than or equal to expression allows you to check that the value associated with an xpath is greater than or equal to another value.

`<value> >= <value>`

Less than

The less than expression allows you to check that the value associated with an xpath is smaller than another value.

`<value> < <value>`

Less than or equal to

The less than or equal to expression allows you to check that the value associated with an xpath is smaller than or equal to another value.

`<value> <= <value>`

MEMBERSHIP (IN)

Membership expressions allow you to check if the value associated to an xpath is present in a set of values. The set of values can be a simple set value or it can come from a codelist.

Set

The in set expression allows you to check if the value associated with an xpath is present in a given set.

`<xpath> in <set>`

Codelist

The in codelist expression allows you to check if the value associated with an xpath is present in a certain codelist.

<xpath> in codelist(<string>, <string>, <set>, <set>, <string>)

The codelist parameters between parentheses correspond to (from left to right):

- Codelist code
- Applicability
- Elements to add
- Elements to remove
- Code key

All the parameters are mandatory but some of them accept empty values.

The set returned by the codelist function is always a set of strings.

EXISTENCE (IS)

The existence expressions allow you to check if an xpath is present or not in the xml under validation.

Required

The required expression allows you to check if the xpath is present in the xml message.

<xpath> is required

This expression should not be used as the condition of an if statement.

Optional

The optional expression allows you to check if the xpath is present or is not present in the xml message.

<xpath> is optional

This expression should not be used as the condition of an if statement.

Forbidden

The forbidden expression allows you to check if the xpath is not present in the xml message.

<xpath> is forbidden

This expression should not be used as the condition of an if statement.

Present

The present expression allows you to check if the xpath is present in the xml message.

<xpath> is present

This expression should only be used as the condition of an if statement.

AGGREGATION

Aggregation expressions allow you to transform multiple results of an expression into a single result.

All

The all expression allows you to verify that all the individual results of a Multiple result are True.

all <expression>

The all expression returns a:

- Unexpected result: when at least one of the individual results of the inner expression is Unexpected.
- False result: when at least one of the individual results of the inner expression is False.
- True result: when all individual results of the inner expression are True.
- The all expression never returns a Multiple result.

At least

The at least expression allows you to verify that at least n individual results of a Multiple result are True.

atleast <number> <expression>

<number> represents the minimum number of individual results that must be True. Note that this number must be an integer number (1, 2, 3, 10, ...). If it is not, an error will occur when you upload the rule.

The at least expression returns a:

- Unexpected result: when at least one of the individual results is Unexpected.
- False result: when the number of True individual results is less than <number>. (This also means when the number of individual results is less than <number>)
- True result: when the number of True individual results is greater or equal to <number>.
- The at least expression never returns a Multiple result.

GROUPING

Grouping expressions allow you to combine the results of 2 subexpressions in a single result.

And

The and expression allows you to apply a logical "and" on the result of 2 expressions.

<expression> and <expression>

The and expression returns a:

- Unexpected result: when at least one of the subexpression results is Unexpected.
- Multiple result: when at least one of the subexpression results is Multiple.
- False result: when at least one of the subexpression results is False.
- True result: when the 2 subexpression results are True.

Or

The or expression allows you to apply a logical “or” on the result of 2 expressions.

<expression or <expression>

The or expression returns a:

- Unexpected result: when at least one of the subexpression results is Unexpected.
- Multiple result: when at least one of the subexpression results is Multiple.
- False result: when the 2 subexpression results are False.
- True result: when at least one of the subexpression results is True.

NEGATION

Not

The not expression allows you to invert the result of another expression.

(not <expression>)

The not expression returns a:

- Unexpected result: when the subexpression result is Unexpected.
- Multiple result: when the subexpression result is Multiple. In this case the not expression also inverts the individual results of the subexpression.
- False result: when the subexpression result is True.
- True result: when the subexpression’ result is False.

IF STATEMENT

The if statement allows you to execute different statements depending on one or more conditions.

if <expression> then

<statement>

elsif <expression> then

<statement>

elsif ...

...

else

<statement>

endif

As a reminder, the role of a statement is to generate errors for one Rule.

The condition(s)

A condition can be any of the expression available in VRE. The condition must return a True or False result. If it returns a Multiple or Unexpected result then the if statement will generate as many errors as there are results. As soon as there is an issue with a condition, the execution of the if statement stops and the other conditions and statement are never executed.

If condition then statement

If the condition result is True, then the if statement will generate the errors of the next statement and the (optional) following conditions are not evaluated. If the result is False, then the next Elself or Else part is executed. If there is no Elself or Else after, then the if statement returns 0 error.

Elsif condition then statement

This part is optional. This part works exactly as the "If condition then statement" does except that it must come after an "If condition then statement" or another "Elsif condition then statement" part.

Else statement

This part is optional. When this part is reached, the if statement will generate the errors of the next statement.

Different forms

If

if <expression> then

<statement>

endif

If else

if <expression> then

<statement>

else

<statement>

endif

If elsif

if <expression> then

<statement>
elseif <expression> then
    <statement>
endif

    If elsif else
if <expression> then
    <statement>
elseif <expression> then

    <statement>
Endif
```

FOREACH STATEMENT

The foreach statement allows you to loop over each value of a multiple xpath. In practice, this means that the inner statement will be executed as many times as there are values associated to the xpath.

```
foreach <xpath>
    <statement>
```

As a reminder, the role of a statement is to generate errors for one Rule.
